The Cochrane Collaboration is an international organisation that aims to help people make well-informed decisions about healthcare by preparing, maintaining and promoting the accessibility of systematic reviews of the effects of healthcare

The Cochrane Oral Health Group (OHG) aims to produce systematic reviews which primarily include all randomised controlled

primarily include all randomised controlled trials (RCTs) in oral health. Oral health is broadly conceived to include the prevention, treatment and rehabilitation of oral, dental and craniofacial diseases and disorders.

The OHG is composed of persons from around the world who share an interest in developing and maintaining systematic reviews relevant to the field of oral health. Reviewers are encouraged to collaborate on reviews and the OHG is able to facilitate contacts with colleagues around the world. The group is co-ordinated by an Editorial Team who edit and assemble completed reviews into modules for inclusion in *The Cochrane Library* (an electronic database updated quarterly).

- RevMan 5! The latest version of the Collaboration's review writing software was officially released on the 14th March. The conversion of all the OHG reviews from RevMan 4 to 5 will be done centrally at the editorial base unless otherwise agreed with the Group Co-ordinator, Luisa Fernandez. This means that if you are in the process of completing your protocol, review or review update you can continue as normal and submit it to us in RevMan 4 format and we will convert it for you before publication. If you register a new title you must begin using RevMan 5 straight away. To learn more about RevMan 5 or to download it and complete the tutorial please go to https://www.cc-ims.net/RevMan.
- **New handbook!** To coincide with the release of RevMan 5 the Collaboration have produced the *Cochrane Handbook for Systematic Reviews of Interventions* Version 5.0.0. It is an essential resource for Cochrane reviewers and is currently available in full in browsable form only at http://www.cochrane.org/resources/handbook/index.htm.
- Release of GRADEpro! This is the software used to create Summary of Findings (SoF) tables in Cochrane systematic reviews. With the release of RevMan 5 and the new Cochrane Handbook, review authors are encouraged to include an SoF table in their review. It is an optional, although strongly recommended, means of presenting findings for the most important outcomes, whether or not evidence for outcomes is available from research studies (i.e. the summary for an outcome may be "no research evidence available"). An SoF table includes, where appropriate: typical absolute risks for people receiving experimental and control interventions; estimates of relative effect (e.g. risk ratio or odds ratio); a depiction of the quality of the body of evidence; comments; and footnotes. The assessment of the quality of the body of evidence should follow the GRADE framework, which combines considerations of risk of bias, directness, heterogeneity, precision and publication bias.
