Editorial - Systematic reviews in dentistry

We have made further excellent progress with our contribution to the Cochrane Library adding two new systematic reviews, one on the treatment of periodontal infra-bony defects and one on treating dentine hypersensitivity.

The Oral Health Group website: www.cochrane-oral.man.ac.uk has been a great success providing information vital to the rapid progress of the Oral Health Group. We have recently included a link to 63 other systematic reviews in dentistry which are included on DARE. DARE (Database of Abstracts of Reviews of Effectiveness) is a database of quality assessed systematic reviews maintained by the NHS Centre for Reviews and Dissemination (CRD), University of York. This includes a summary of the review plus a critical assessment. Members of the Oral Health Group are currently independently evaluating these reviews and will report back soon.

CRD has also conducted a review on water fluoridation which should be of great interest to OHG members. This can be accessed on http://www.york.ac.uk/inst/crd/fluorid.htm



We are sad to report the death of Donald Macfarlane who had been a leading member of our journal handsearching team since the start of our programme in 1997. Donald, joined us well into his retirement which followed a long and impressive career as a dentist, working first in practice and later as Head of the Dental Hygienists' School, and a lecturer at Guy's Hospital London. He also served on a number of National and International organisations and learned societies. Through his work he leaves a number of legacies to the dental profession, not least through his work for the Cochrane Collaboration, where he has made a considerable contribution to the worldwide journal handsearching programme through his search of a wide range of dental journals and in particular the periodontal literature.

9th International Cochrane Colloquium

9-13 October 2001

Palais des Congres, Lyon, France

The 9th International Cochrane Colloquium is to be held in Lyon, France from 9-13 October 2001. The objectives of the Colloquium are:

- To introduce the Cochrane Collaboration, its achievements and its plans to all those interested in using the best available evidence for the planning and delivery of health care
- To provide an opportunity for those producing systematic reviews to meet and to make progress in their work.
- To provide an opportunity to examine how systematic reviews can be effectively disseminated and used in evidence-based practice.
- To create a forum for discussions of barriers to the production of evidence relevant to patient care and its implementation.
- To discuss potential alliances among consumers, policy makers, administrators, clinical researchers, clinicians, funders and industry in the health care arena.

Collaboration News

Reviews on MEDLINE

MEDLINE now lists Cochrane reviews along with their abstracts (this excludes protocols). The full journal name is 'The Cochrane Database of Systematic Reviews [Computer file]' and the official MEDLINE abbreviation is 'Cochrane Database Syst Rev'.

If you 'substantially update' your review this merits a second entry. MEDLINE can be viewed for free athttp://www.nlm.nih.gov/databases/freemedl.html

JAMA welcomes systematic reviews

The editors of JAMA have recognised the high quality of Cochrane systematic reviews and after examining their journal policies believe that they provide very few barriers to good new Cochrane reviews at the cutting edge of medicine.

JAMA's policy regarding Cochrane systematic reviews and manuscripts is that in general, they like to publish the message before it appears in the Cochrane Library. However, manuscripts are handled on an individual basis and they are certainly prepared to consider for publication manuscripts describing reviews that have already appeared in the Cochrane Library. Obviously, the message of the two reports would be the same even though the reports themselves may eventually differ. JAMA would, of course, obtain its own peer review which will usually result in revisions.

The Lancet's new publication policy for Cochrane Reviews

The Lancet has proposed a new policy for the publication of Cochrane reviews in acknowledgement of the overwhelming evidence that Cochrane reviews are of higher quality than non-Cochrane reviews. The Lancet will welcome the submission of completed and approved Cochrane reviews, published or not on the Cochrane Library, for subsequent publication in The Lancet.

The review would have to conform to the Lancet's usual MS requirements and be subject to the journal's own peer review process. A reference and a web link would be made to the original Cochrane review to avoid confusion over dual publication.

It is hoped that this new policy will not only increase the number of high-quality systematic reviews published in The Lancet but also help to disseminate Cochrane reviews to clinicians. Richard Horton, The Lancet
